I do further hereby certify that, to the best of my knowledge, I suffer from no physical condition which would in any way place me in danger by virtue of my participation in this event.



**Route Options:**

**Chief Ladiga Trail**— ride to the Alabama/Georgia line on the trail! You choose the distance up to 75 miles.

**100 Miles**— Includes two tough climbs, one in the Talladega National Forest east of Piedmont and one on Baines Gap Road through the Mountain Long Leaf National Wildlife Refuge at McClellan.

*For those wanting a challenge, but not the full 100, you will have the opportunity to leave the Ladiga Trail with the 100 mile riders and finish that route. You will be making the two tough climbs on the road route.*

All routes will be clearly marked.

Rest stops, SAG vehicles, a souvenir T-Shirt, a post-ride meal, and excellent radio communications are provided to make your ride as pleasurable and memorable as possible.

Registration begins at 6:30 a.m.  
All riders must check in at registration.  
Ride begins at 7:30 a.m.
- LOCATION:** Woodland Park Athletic Facility  
901 East Glade Road  
Anniston, Alabama
- ELIGIBILITY:** Ride is open to all cyclists regardless of age, sex, or ability. A separate waiver form must be filled out on the day of the ride if you are under 19.
- RIDER SUPPORT:** Rest stops along the route will be stocked with fruit, light snacks, water and PowerAde. Official vehicles will be constantly patrolling the course throughout the event.
- AWARDS:** Souvenir T-Shirts are guaranteed on ride day if registration and check are received by March 17, 2010.
- REGISTRATION:** \$25.00 if received by March 17  
\$30.00 thereafter & day of race.
- HELMETS:** Helmets are required by all riders!
- POST-RIDE MEAL:** A post-ride meal will be provided.
