A RESOLUTION DIRECTING THAT A CERTIFICATE OF ELECTION BE GIVEN TO _____ ENTITLING SAID INDIVIDUAL TO HOLD OFFICE AS THE BOARD OF EDUCATION MEMBER FROM WARD 1 UNTIL THE NEXT ELECTION

WHEREAS, on to wit, August 21, 2014, Donna Satterlee Ross resigned from the position of Board of Education Member from Ward 1 in the City of Anniston, thereby creating a vacancy on the Anniston City Board of Education; and

WHEREAS, under Section 6 of Act No. 306, S, 629, Regular Session 1998 (Acts of Alabama, 1998, p. 516), it is provided that any vacancy in the Anniston City Board of Education shall be filled by the City Council; and

WHEREAS, the City Council of the City of Anniston, Alabama on September 15, 2014 in the discharge of the duties required of it by law, cast votes in an open special called meeting for a qualified person to fill the vacancy on the Anniston City School Board as Board Member representing Ward 1 for the un-expired term of former Board of Education Member Donna Satterlee Ross.

NOW, THEREFORE, the City Council of the City of Anniston, Alabama, does hereby Find, Resolve and Declare as follows:

Section 1. That upon motion duly made and seconded, _____ was nominated and elected by a majority vote of all the Council Members present to the position of Board of Education Member Ward 1 for the un-expired term of former Board of Education Member Donna Satterlee Ross.

Section 2. That a Certificate of Election signed in the name of the City Council by its members, and attested by the City Clerk shall be given to the said _____ which entitle him/her to the position of this respective office immediately.

Section 3. That the City Clerk shall file a copy of the Certificate of Election in the Office of the Judge of Probate of Calhoun County.
