The City Council of the City of Anniston, Alabama, met in Regular Session in the Council Chamber in the City Hall of the City of Anniston, Alabama, on Monday, October 13, 2014, at approximately 5:39 o'clock p.m.

Lee McNeil prayed the Invocation.

Council Member Jenkins stated he would abstain from voting on this bid. He stated he would receive no financial gain from this project but stated that he did have a financial relationship with the architect.

Council Member Harris made a motion that the bid in the total amount of \$1,748,242.00 by Hurst Construction for a new Fire Station be accepted. Council Member Harris stated that this coming week would mark the end of any unexploded ordnance located at McClellan.

Council Member Selase reminded everyone of the importance of the proclamations for Red Ribbon Week and National Domestic Awareness Month passed that night. He thanked the local bars and restaurants for adjusting to the City's comprehensive smoking ordinance. He stated the City had experienced a \$10,000 increase in yearly sales tax revenue from these establishments since the passage of the ordinance.

Council Member Jenkins thanked Larry May and Robert Jackson for putting on an outstanding concert recently. He stated he would like for the Council to look at the smoking ordinance in respect to cigar bars.

Mayor Stewart stated that the Police Citizen Advisory Council had their first meeting last week and it had been very productive. He stated they had an excellent zoning workshop for citizens last week.
