Speaking to a Public Hearing Item

In the interest of time and to ensure the fairness of all persons who appear before the City Council to speak for or against a public hearing item, speakers will be limited to three (3) minutes each to address City Council except as described herein. One speaker for the Petitioner may address the City Council for no more than 10 minutes, unless extended by the Mayor. In an effort help the City Council and the general public to better understand the issues, the Mayor may request that a City staff member address the City Council from the podium. Speakers from the general public may only speak when recognized by the Mayor during the public hearing. Speakers will be asked to come to the podium to address the City Council for three (3) minutes and they shall state their name and resident address for the record. Speakers addressing City Council on a public hearing item should coordinate comments in order to respect City Council's time constraints. Groups should select a spokesperson to present the major points that summarize their position and opinions. Speakers are urged to be brief and non-repetitive with their comments. Comments shall specifically address the public hearing item before the City Council, and the speaker shall maintain appropriate tone and decorum when addressing the City Council. City Council may ask questions of the applicant, speakers, or staff during these proceedings only for the purpose of clarifying information. The speaker shall not direct derogatory comments to any individual, organization, or business. At the conclusion of the three (3) minute time period, the speaker will be notified that his/her time has elapsed and the next speaker will be recognized to come forward to the podium and address the City Council. Once the public hearing is closed on an item, there will be no further opportunity for formal or informal public input at a City Council meeting.

MINUTES

Anniston, Alabama

December 15, 2020

The City Council of the City of Anniston, Alabama, met in Regular Session in Room B at the Anniston City Meeting Center in the City of Anniston, Alabama, on Tuesday, December 15, 2020, at approximately 5:30 o'clock p.m.

Keith Screws, Pastor of Greenbrier Road Baptist Church, prayed the Invocation.

Keith Screws, Pastor of Greenbrier Road Baptist Church, led the Pledge of Allegiance to the Flag.

Mayor Draper called the meeting to order. On call of the roll, the following Council Members were found to be present: Council Members Jenkins, Roberts, Smith, Harris, and Draper, absent: none. A quorum was present and the meeting opened for the transaction of business.

Steven Folks, City Manager, was present.

Council Member Jenkins made a motion to waive the reading of and approve the minutes of the December 1, 2020 Regular meeting. The motion was seconded by Council Member Roberts and on call of the roll the following vote was recorded: ayes: Council Member Jenkins, Roberts, Smith, Harris, and Draper; nays: none. The motion carried and the December 1, 2020 Regular Meeting minutes were approved.

Council Member Harris made a motion to adopt the agenda with the addition of Jennifer Maddox presenting a brief update on the Small Business Relief. The motion was seconded by Council Member Smith and on call of the roll the following vote was recorded: ayes: Council Member Jenkins, Roberts, Smith, Harris, and Draper; nays: none. The motion carried and the amended agenda was adopted.

Jennifer Maddox, Community Foundation of Northeast Alabama, updated the council on the small business relief fund. She stated that round three they have received 82 applications, totaling \$400,009.76 in requests. She stated of those applications, 44 are businesses located in Anniston totaling requests of \$222,009.76. She stated that they currently have available to grant without any further donations \$81,464.07 for a total of 400,000.00 in requests. She stated that the council's support is really important.

Council Member Jenkins asked if the \$81,464.07 dollars that is still available, does that include the monies the council are preparing to allocate tonight.

Jennifer Maddox stated that whatever the council allocated would bolster that amount.

Council Member Roberts asked if the money they have currently include what is due to the City of Oxford.

Jennifer Maddox stated that of the \$81,000.00 approximately \$20,000.00 is Oxford money that was not spent on prior rounds. And the other \$60,000.00 came from other donors.

Mayor Draper stated that he appreciates the Community Foundation for their administration of the fund. He stated this has been a good partnership between local governments, the business community, and the non-profit community. He stated that this has been a great example of cooperation.

Jennifer Maddox stated that the Community Foundation does not charge a fee for disaster work. She stated that all the work they are doing is for free, so 100% of the donations put in go directly to the businesses.

Council Member Jenkins made a motion to approve the consent agenda:

- (a) Resolution authorizing reimbursements to city officials for expenses incurred while traveling away from the City (20-R-92)
- (b) Resolution declaring a reported condition to be a public nuisance (20-R-93)
- (c) Resolution appointing member(s) to the Anniston Museum of Natural History Board (20-R-94)
- (d) Resolution establishing policy for adoption of ordinances to amend Traffic Schedules (20-R-95)
- (e) Motion to approve adding an additional \$50,000.00 to the Small Business Relief Fund administered by the Community Foundation of Northeast Alabama.

The motion was seconded by Council Member Smith and on call of the roll the following vote was recorded: ayes: Council Member Jenkins, Roberts, Smith, Harris, and Draper; nays: none. The motion carried and the consent agenda was adopted.

Mayor Draper introduced Resolution authorizing Tax Rebate Agreement between the City of Anniston, Alabama and Blackwater Development Company, LLC.

Council Member Jenkins made a motion for passage and adoption. The motion was seconded by Council Member Harris.

Council Member Jenkins stated how exciting this is to have a great partner in Blackwater and this is the tip of the iceberg for the City.

Mayor Draper thanked John Abernathy with Blackwater Development and he appreciates all the work they have put into this along with city staff.

And on call of the roll the following vote was recorded: ayes: Council Member Jenkins, Roberts, Smith, Harris, and Draper; nays: none. The motion carried and Resolution 20-R-96 was passed and adopted.

There being no further business to come before the council at that time Mayor Draper made a motion the meeting be adjourned. The motion was seconded by Council Member Harris; and on call of the roll, the following vote was recorded: ayes: Council Members Jenkins, Roberts, Smith, Harris and Draper; nays: none. The motion carried and the meeting was adjourned at approximately 5:45 o'clock p.m.
