#### A RESOLUTION DECLARING A REPORTED CONDITION TO BE A PUBLIC NUISANCE

**WHEREAS,** <u>Tana Bryant</u>, an Appropriate City Official, pursuant to Section 34.7 and 34.15 of said Ordinance, has reported to the City Council that conditions exist at <u>see attached</u> <u>(Group 2021-03 Grass/Debris/Vehicles)</u> in Anniston, Alabama that are believed to be a public nuisance; and

**WHEREAS,** the said City official submitted proof of said condition that was deemed by the City Council to be satisfactory to show that a public nuisance existed at the place specified; and

WHEREAS, Section 34.3 (b) (1), (2), (4) of the City of Anniston Ordinance No. 11-0-9 declares the following conditions to be a public nuisance: overgrown lots, maintenance or storage of motor vehicles that are not in usable condition as defined in Section 34.2 of the Code of Ordinances and debris, motor vehicles and trash; and

**RESOLVED THEREFORE,** that a public nuisance exists at the above said locations within the City of Anniston, said property being more particularly described on **Exhibit "A"** to this resolution; and

**RESOLVED FURTHER,** that the public nuisance must be abated by the City and the cost of abatement charged as a lien against the property if not remedied by the owner(s); and

**RESOLVED FURTHER,** that a hearing be set before the City Council at its next regular scheduled meeting to hear objections to the City's actions; and

**RESOLVED FURTHER,** that at least two NOTICES TO REMOVE PUBLIC NUISANCE be promptly posted by the Appropriate City Official in front of the said property at not more than 100 feet in distance apart as specified in Section 34.16 of the Code of Ordinances; and

**RESOLVED FURTHER,** that the Appropriate City Official shall post said NOTICE TO REMOVE PUBLIC NUISANCE, as aforesaid, at least 5 days prior to the time for hearing objections by the City Council; and

**RESOLVED FURTHER,** that the Appropriate City Official shall determine the name and address of the person or entity last assessing said property for tax purposes, and shall further cause a search to be made of the public records, and shall further make a diligent investigation to discover the name(s) and contact information of the owners of every beneficial interest in the said property; and

**RESOLVED FURTHER,** that the Appropriate City Official shall, at least 5 days prior to the time for a hearing of objections by the City Council, mail a copy of said Notice by certified or registered mail, with postage prepaid and return receipt requested, to the last person/entity assessing the property for taxes and to each owner of a beneficial interest in said property including, without limitation, mortgagees of record.

## A RESOLUTION OVER-RULING OBJECTIONS TO THE ABATEMENT OF IDENTIFIED NUISANCES CAUSED BY UNSAFE BUILDINGS, STRUCTURES, OR CONSTRUCTION

**WHEREAS,** Act 1995-375, as amended by Act 2004-256 and codified as Ala. Code § 45-8-172, *et seq.*, and Act 2002-522, codified as Ala. Code § 11-53B-1, *et seq.*, establish unsightly or dangerous walls, abandoned or unsafe construction of any kind or nature, and unsafe buildings and structures, or parts thereof, to be public nuisances and further authorize the City to order or otherwise accomplish the removal of such nuisances;

**WHEREAS,** the City of Anniston declared the properties identified herein as being such public nuisances, notified the appropriate persons and entities, as required by law, directed said persons and entities to accomplish the necessary repairs or demolition to abate the nuisance conditions, and further notified said persons that the City may accomplish the repairs or demolition, as the case may be, and assess the costs thereof against the property if not made within the time specified in the respective notices;

**WHEREAS**, the public nuisances identified herein remain and the time prescribed for their voluntary abatement has expired;

**WHEREAS**, the Council has held a public hearing to consider objections to the identified public nuisances and the remedies deemed necessary to abate the same;

**NOW THEREFORE, BE IT RESOLVED**, by the Council for the City of Anniston, Alabama as follows:

Section 1. Upon due consideration, the Council hereby over-rules those objections and protests made with respect to the nuisances and remedies identified in Exhibit "A", attached hereto. The Council directs the appropriate city officials to enforce the abatement of said nuisances and apply the recommended remedies in accordance with Chapter 34, Article III of "The Code of the City of Anniston, Alabama, 1981" and as otherwise specified or authorized by the laws of the State of Alabama, and to take such actions in the time, order, and manner deemed necessary or appropriate in light of the City's budgetary, resource, and administrative constraints.

Section 2. The Fire Marshal, of his designee, is further directed to file notice in the Office of the Judge of Probate for Calhoun County, Alabama with respect to each property identified herein, which notice shall identify the necessary parties, provide a description of the real estate, and state the City of Anniston's intention, by this Resolution of the Council, to abate the identified nuisance, accomplish the recommended remedy, as the case may be, and to assess the costs thereof against the land. Said notice shall be filed in the property records of the Office of the Judge of Probate so as to provide record notice of the pending proceedings to those interested persons, including any subsequent purchasers of the land, and to promote due process with respect to the actions taken as a result of this Resolution.

## **ORDINANCES**

#### ORDINANCE NO. 21-0-

### AN ORDINANCE AMENDING SECTION 15.49 OF THE CODE OF ORDINANCES OF THE CITY OF ANNISTON, ALABAMA DESIGNATING AN ALLEY AS ONE WAY IN THE DIRECTION INDICATED

**BE IT ORDAINED** by the City Council of the City of Anniston, Alabama as follows:

Section 1. The City Council of the City of Anniston, Alabama hereby amends the following Sections of "The Code of City of Anniston, Alabama, 1981" as follows:

Section 2. That Section 15.49 of the Code of Ordinances of the City of Anniston, Alabama is hereby amended to read in its entirety:

#### Section 15.49. One-way streets and alleys.

Upon those streets and alleys, or parts thereof, for one-way traffic, vehicular traffic shall move only in the indicated direction when signs indicating the location of traffic are erected and maintained at every intersection where movement in the opposite direction is prohibited.

The following streets and alleys, or parts thereof, are designated as one-way in the direction indicated:

- (a) Atlanta Avenue, from 10th Street to 11th Street, southbound traffic only.
- **(b)** Andre Franklin Drive, from Moses Street to the intersection of Andre Franklin Drive with the east right-of-way line of Zinn Parkway Drive, northbound traffic only.
- (c) Cooper Avenue, from the south line of 14th Street 120 feet south, northbound traffic only.
- (d) Elizabeth Avenue, from 10th Street, southbound traffic only between the hours of 7:00 a.m. to 7:45 a.m. and 2:00 p.m. to 2:45 p.m. on Mondays through Fridays when school is in session; at all other times, such portion of Elizabeth Avenue shall remain a two-way street.
- (e) King Street, from the north/south alley between Mulberry Avenue and Cooper Avenue to the west line of Mulberry Avenue, eastbound traffic only.
- (f) McCoy Avenue, from 24th Street to 27th Street, northbound traffic only.
- (g) Rockridge Drive, from Leighton Avenue to 25th Street, eastbound traffic only.
- (h) Walnut Avenue, from 25th Street to 27th Street, southbound traffic only.
- (i) Zinn Parkway Drive, from its intersection with Andre Franklin Drive to Moses Street, southbound traffic only.
- (j) Alley between Noble Street on the west, and Wilmer Avenue on the east, from a point at its intersection with 8th Street to a point 200 feet south of its intersection with 9th Street, northbound traffic only.
- (**k**) Alley between Noble Street on the west and Wilmer Avenue on the east and between 10th Street on the south and 13th Street on the north, southbound traffic only.
- (I) Alley between Park Avenue to 7th Street, the directional traffic on such alley shall proceed from the place where the alley intersects with Park Avenue and curve with the alley to the place where the alley intersects at 7th Street.
- (m) Alley between Quintard Avenue and Leighton Avenue, from 10th Street to 11th Street, northbound traffic only.
- (n) Alley between 10th Street and 11th Street, and Fairmont Avenue and Woodstock Avenue, westbound traffic only.
- (o) First alley east of Gurnee Avenue, from 11th Street south to 10th Street, southbound traffic only.

- (**p**) Reserved.
- (q) First east/west alley south of "A" Street between South Leighton Avenue and South Allen Avenue, westbound traffic only.
- (r) First north/south alley west of Keith Avenue, between 9th Street and 10th Street, northbound traffic only.
- (s) North/south alley, between Mulberry Avenue and Cooper Avenue, from 14th Street to 12th Street, southbound traffic only.
- (t) First alley east of Noble Street, from 13th Street south to 10th Street north, southbound traffic only and from 10th Street south and 9th Street north, northbound traffic only.
- (u) First alley west of Noble Street, from a point 150 feet north of 9th Street to 13th Street, northbound traffic only.
- (v) First alley east of Quintard Avenue, from 17th Street to 18th Street, northbound traffic only.
- (w) First alley east of Wilmer Avenue, from 14th Street south to 12th Street, southbound traffic only, from 10th Street south to 9th Street, southbound traffic only.
- (x) First alley north of 7th Street, between Lapsley Avenue and Keith Avenue, westbound traffic only.
- (y) First alley north of 10th Street, between Gurnee Avenue and Moore Avenue, westbound traffic only.
- (z) Oak Street from Highland Avenue to Keith (north segment), west bound traffic only.

Section 3. That this Ordinance shall become effective immediately upon its adoption and publication one (1) time in <u>The Anniston Star</u>, a newspaper of general circulation published in the City of Anniston, Alabama, and the City Clerk is hereby directed to cause a copy of this Ordinance to be published one time in said newspaper.

# AN ORDINANCE AMENDING SECTION 15.57 OF THE CODE OF ORDINANCES OF THE CITY OF ANNISTON, ALABAMA ADDING FOUR-WAY STOP INTERSECTIONS

**WHEREAS,** the City Council of the City of Anniston (the "Council") finds that a four-way stop sign is due to be installed on Fairway Drive at its intersection with Glenwood Terrance and Sunset Pass; and

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Anniston, Alabama as follows:

Section 1. The City Council of the City of Anniston, Alabama hereby amends and restates Section 15.57(c) of "The Code of the City of Anniston, Alabama, 1981" in its entirety to read as follows:

**Sec. 15.57. - Four-way stop intersections.** When stop signs or signals are erected giving notice thereof, it shall be unlawful for any person driving or operating a vehicle to enter any four-way stop intersection from any direction without coming to a complete stop before entering such intersection. The following are hereby designated as four-way stop intersections:

- (c) All roadways beginning with the letter "F" through "K":
  - (1) Fairway Drive, at its intersection with Glenwood Terrace and Sunset Pass
  - (2) Fairway Drive, at the southernmost intersection with Sunset Drive.
  - (3) Front Street, at its intersection with J Street.
  - (4) Glenwood Terrace, at its intersection with Jefferson Avenue.
  - (5) Glenwood Terrace, at its intersection with Kirkwood Avenue.
  - (6) Glenwood Terrace, at its intersection with Lockwood Avenue.
  - (7) Goodwin Avenue, at its intersection with 5th Street.
  - (8) Goodwin Avenue, at its intersection with 6th Street.
  - (9) Greenbrier Drive, at its intersection with Cloverdale and Robertson Roads.
  - (10) Gurnee Avenue, at its intersection with 10th Street.
  - (11) Gurnee Avenue, at its intersection with 11th Street.
  - (12) Highland Avenue, at its intersection with 11th Street.
  - (13) Johnson Avenue, at its intersection with Maple Street.
  - (14) Johnston Drive, at its intersection with Altamont Avenue.
  - (15) Johnston Drive, at its intersection with Bacon Avenue

Section 2. That this Ordinance shall become effective immediately upon its adoption and publication one (1) time in <u>The Anniston Star</u>, a newspaper of general circulation published in the City of Anniston, Alabama, and the City Clerk is hereby ordered and directed to cause a copy of this Ordinance to be published one time in said newspaper.

#### ORDINANCE NO. 20-0-\_\_

## AN ORDINANCE AMENDING SECTION 15.58 OF THE CODE OF ORDINANCES OF THE CITY OF ANNISTON, ALABAMA REMOVING A TWO-WAY STOP INTERSECTION

WHEREAS, the City Council of the City of Anniston (the "Council") finds that a two-way stop sign is due to be removed at Fairway Drive at its intersection with Glenwood Terrance and Sunset Pass;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Anniston, Alabama as follows:

Section 1. The City Council of the City of Anniston, Alabama hereby amends and restates Section 15.58 Section C of "The Code of the City of Anniston, Alabama, 1981" in its entirety to read as follows:

**Sec. 15.58. - Stop intersections generally.** When stop signs or signals are erected giving notice thereof, it shall be unlawful for any person driving or operating a vehicle to enter any of the first named streets in such list without first coming to a complete stop before entering such first named street:

Section C. All streets beginning with the letter "F" as follows:

- (1) Fairway Drive, at its intersection with Canyon Drive.
- (2) Fairway Heights, at its intersection with Rebecca Trail, vehicles approaching in a southerly direction.
- (3) Federal Way, at its intersection with Castle Avenue.
- (4) Federal Way, at its intersection with Goode Road.
- (5) Federal Way, at its intersection with Lennox Avenue.
- (6) Foxley Road, at its intersections with Lamp Road.
- (7) Foxley Road, at its intersection with Wirans Road.
- (8) Foxmoore Place, at the northeast corner of its intersection with Old Coach Road.
- (9) Front Street, at its intersection with J Street.

Section 2. That this Ordinance shall become effective immediately upon its adoption and publication one (1) time in The Anniston Star, a newspaper of general circulation published in the City of Anniston, Alabama, and the City Clerk is hereby ordered and directed to cause a copy of this Ordinance to be published one time in said newspaper.
