#### I. PUBLIC HEARING

#### Speaking to a Public Hearing Item

In the interest of time and to ensure the fairness of all persons who appear before the City Council to speak for or against a public hearing item, speakers will be limited to three (3) minutes each to address City Council except as described herein. One speaker for the Petitioner may address the City Council for no more than 10 minutes, unless extended by the Mayor. In an effort help the City Council and the general public to better understand the issues, the Mayor may request that a City staff member address the City Council from the podium. Speakers from the general public may only speak when recognized by the Mayor during the public hearing. Speakers will be asked to come to the podium to address the City Council for three (3) minutes and they shall state their name and resident address for the record. Speakers addressing City Council on a public hearing item should coordinate comments in order to respect City Council's time constraints. Groups should select a spokesperson to present the major points that summarize their position and opinions. Speakers are urged to be brief and non-repetitive with their comments. Comments shall specifically address the public hearing item before the City Council, and the speaker shall maintain appropriate tone and decorum when addressing the City Council. City Council may ask questions of the applicant, speakers, or staff during these proceedings only for the purpose of clarifying information. The speaker shall not direct derogatory comments to any individual, organization, or business. At the conclusion of the three (3) minute time period, the speaker will be notified that his/her time has elapsed and the next speaker will be recognized to come forward to the podium and address the City Council. Once the public hearing is closed on an item, there will be no further opportunity for formal or informal public input at a City Council meeting.

#### VI. PUBLIC COMMENTS

#### Public Comment – Speaker Protocol

The City of Anniston believes that any member of the general public should be afforded the opportunity to address the City Council provided that designated rules are followed by the speaker. Any member of the public, who wishes to address the City Council and offer public comment on items within the City Council's jurisdiction, may do so during the Public Comment period of the meeting. However, no formal action will be taken on matters that are not part of the posted agenda. In order to ensure the opportunity for all those desiring to speak before the Council, there is no yielding of time to another speaker. This opportunity to address City Council may not be used to continue discussion on an agenda item that has already been held as a public hearing. Matters under negotiation, litigation, or related to personnel will not be discussed. Members of the general public who would like to address the City Council during the Public Comment portion of the meeting, may do so in accordance with the rules outlined in Ordinance 21-0-22 adopted by the City Council on November 2, 2020 as stated:

Section 12. Members of the public may address the Council or speak on matters of public concern during the period of the meeting agenda reserved for public comments, subject to the following procedures:

(a) No person shall be allowed to speak during public comments unless he or she submits a Request to Speak During Public Comments form to the Office of the City Manager no later than 3:00 P.M. on the Friday before the Council meeting. The request shall identify the speaker by name and residential address and shall specify the date of the meeting in which the speaker desires to offer public comments.

(b) The period for public comments shall be open to the first ten (10) persons who submit a timely request to speak during the meeting at hand.

(c) In advance of each meeting, the City Manager shall provide the Council a list of the persons authorized to speak during the period for public comments, not to exceed ten (10) persons, which shall identify the speakers in the order in which their requests were made. The presiding officer shall call on each person from the list. Once recognized, each person shall be provided no more than three (3) minutes to complete his or her public comments.

(d) Those persons who make a timely request, after the first ten (10) requests, shall be first on the list of persons authorized to speak during the period for public comments in the next meeting, unless he or she asks to be removed from the list.

Section 13. All comments made by members of the Council shall be restricted to the matter under consideration and shall be addressed to the presiding officer, except during the period of the meeting reserved for Council Comments. All comments made by members of the Council shall be restricted to three (3) minutes, unless the presiding officer grants exception for good cause.

Section 14. No comments shall be permitted by a member of the Council or by a member of the public that is of a disparaging nature or which would constitute a personal attack on the integrity of any member of the Council or the staff of the City.

Once the speaker has been recognized to speak, he/she should not attempt to engage the City Council and/or Staff in a discussion/dialogue and the speaker should not ask specific questions with the expectation that an immediate answer will be provided as part of the three (3) minute time frame since that is not the intent of the Public Comment period. If the speaker poses a question or makes a request of the City, the Mayor may refer the issue or request to the City Manager for follow up. At the conclusion of the three (3) minute time period, the speaker will be notified that his/her time has elapsed and the next speaker will be recognized to come forward to the podium and address the City Council. The Mayor may rule out of order any Speaker who uses abusive or indecorous language, if the subject matter does not pertain to the City of Anniston, or if the Speaker(s) attempts to engage the City Council Members in a discussion or dialogue on issues. City Council shall not discuss non-agenda matters because it does not give the public adequate notice. Accordingly, City Council shall be limited to respond to respond to any of a variety of issues on which they may or may not be prepared to respond to on a moment's notice, so the City Manager may respond, or direct staff to respond at later time.

#### **RESOLUTION NO. 22-R-\_\_\_**

#### A RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION FOR FINANCIAL ASSISTANCE UNDER SECTION 5310 OF THE FEDERAL TRANSIT ACT AMENDMENTS OF 1991

**WHEREAS,** Federal financial assistance as authorized under Section 5310 of the Federal Transit Act Amendments of 1991, is available through the Alabama Department of Transportation to provide transportation services to meet the special needs of seniors and individuals with disabilities; and

WHEREAS, the submission of an application for said financial assistance for a High Roof Transit Van is deemed necessary to aid in addressing the transportation needs of seniors and individuals with disabilities residents of the City of Anniston; and

# ORDINANCES

## ORDINANCE NO. 22-O-\_\_\_

## ESTABLISHING POLICE RESERVE FORCE

WHEREAS, the Council recognizes that certain sworn officers of the Anniston Police Department desire to continue their service to the community after their retirement from the department;

WHEREAS, Alabama law allows a city's appointing authority to appoint, with or without compensation, one or more reserve law enforcement officers to assist or aid full-time or part-time certified law enforcement officers;

WHEREAS, the Council desires to establish a reserve police force comprised of persons appointed by the City Manager, upon recommendation of the Chief of Police, who have retired in good standing with the Anniston Police Department after at least 20 years of service and who remain in good standing with the Alabama Peace Officers Standards and Training Commission;

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Anniston, Alabama as follows:

<u>Section 1</u>. The Council hereby enacts and codifies Chapter 24, Police Department, Article IV, Reserve Police Force, Sections 24.24 through 24.29 of "The Code of the City of Anniston, Alabama, 1981", to state in its entirety as follows:

## **ARTICLE IV. - RESERVE POLICE FORCE**

## Sec. 23.24. - Establishment.

There shall be a reserve police force of the Anniston Police Department comprised of reserve law enforcement officers appointed by the City Manager, without compensation, to assist or aid the Anniston Police Department's certified law enforcement officers, as authorized by Ala. Code § 11-43-210.

## Sec. 23.25. – Qualifications; appointment; and removal.

(a) *Qualifications*. No person shall be appointed as a reserve law enforcement officer or permitted to serve on the reserve police force unless (i) he or she retired from the Anniston Police Department in good standing after no less than 20 years of service as a certified law enforcement officer, and (ii) he or she is in good standing with the Alabama Peace Officers Standards and Training Commission ("APOSTC") at the time of appointment and so long as he or she serves as a reserve law enforcement officer.

(b) *Appointment*. Any person desiring appointment as a reserve law enforcement officer must submit a written application to the Chief of Police prior to the effective date of his or her retirement from the Anniston Police Department. The City Manager may appoint any person as a reserve law enforcement officer who (i) submits a timely application, (ii) meets the qualifications set forth in Subsection (b), above, and (iii) is recommended for appointment by the Chief of Police.

(c) *Removal.* Any person appointed as a reserve law enforcement officer shall serve at the pleasure of the City Manager and may be terminated or discharged from the position and removed from the reserve police force by the City Manager at any time, for any reason, or for no reason at all. The City Manager's removal of a reserve law enforcement officer shall not be subject to review. The City Manager may terminate, discharge, or remove a reserve law enforcement officer without providing prior notice, a hearing, or an opportunity to be heard to the reserve law enforcement officer. Whenever the Chief of Police determines, in his or her discretion, it is in the best interests of the Anniston Police Department, the Chief of Police may suspend a reserve law enforcement officer from service in the reserve police force, for a period of time or indefinitely, or revoke any rights, authorities, and privileges granted to a reserve law enforcement officer.

# Sec. 23.26. – Supervision; equipment.

(a) *Supervision*. The reserve police force and the persons appointed as reserve law enforcement officers shall serve under the control and supervision of the Chief of Police or a certified law enforcement officer designated by the Chief of Police. The Chief of Police shall provide for the organization and training of any reserve law enforcement officers. The Chief of Police shall establish such rules and regulations as may be necessary and appropriate for the efficient, effective, and lawful operation of the reserve police force.

(b) *Equipment.* Each reserve law enforcement officer appointed to serve in the reserve police force shall be issued a reserve officer's identification card, a radio, and a reserve officer's badge. He or she must abide by the uniform rules of the Anniston Police Department. The reserve officer shall be responsible for providing at his or her own expense any required equipment including uniforms, duty gear, and boots. The reserve officer shall return any items or equipment provided by the Anniston Police Department upon his or her withdrawal, discharge, or removal from the reserve police force.

## Sec. 23.27. – Duties; compensation.

(a) *Duties.* Reserve law enforcement officers shall perform the duties assigned by the certified law enforcement officer designated by the Chief of Police to supervise the reserve police force upon the reserve officer's report to his or her post. The duties of reserve law enforcement officers shall be limited to crowd control assistance, special events, traffic direction and control, and other non-emergency situations where the reserve police force can supplement the active police force and the reserve officers can act under the supervisory control of a certified law enforcement officer whose total span of control would be considered within reasonable limits. Reserve law enforcement officers shall not engage in patrol operations performed for the purpose of detection, prevention, and suppression of crime or the enforcement of the traffic or highway laws of the city

or state unless specifically assigned those duties by the Chief of Police or his or her designee and only when the reserve officer is accompanied by a certified law enforcement officer employed within the Anniston Police Department.

(b) *Compensation*. Reserve law enforcement officers appointed to the reserve police force shall serve without compensation from the City of Anniston and its police department. A reserve law enforcement officer may receive compensation for outside work when the rules, regulations, standard operating procedures, and protocols of the Anniston Police Department would allow a certified law enforcement officer employed in the department's active police force to perform and receive compensation for the same work.

# Sec. 23.28. - Weapons and training; arrest powers; and call to active duty.

(a) *Weapons and training*. Reserve law enforcement officers may carry and use firearms only to the extent permitted by the Anniston Police Department's rules, regulations, procedures, and protocols. Each reserve law enforcement officer shall be required to qualify with their firearms within the guidelines of the Anniston Police Department and APOSTC rules and regulations. The Anniston Police Department will be keep and report to APOSTC each reserve law enforcement officer's firearms qualifications in the same manner as certified law enforcement officers employed by the department. The Anniston Police Department will provide the training needed for reserve law enforcement officers to retain APOSTC certification, and the department will report the training hours to APOSTC so that the reserve officers remain in good standing with APOSTC. The reserve law enforcement officers shall be responsible for payment of any fees associated with training provided by the Anniston Police Department.

(b) *Arrest Powers*. A reserve law enforcement officers may exercise powers of arrest while performing duties assigned by the Chief of Police or his or her designee provided (i) he or she has completed all training requirements of the APOSTC, (ii) he or she is up to date on all APOSTC training requirements, and (iii) he or she is in good standing with all APOSTC rules and regulations.

(c) *Call to Active Duty.* The Chief of Police may call a reserve law enforcement officer to active duty when necessary to supplement the Anniston Police Department's active duty police force.

# Sec. 23.29. – Violations; penalties.

(a) Violations.

(1) It shall be a misdemeanor for any person not appointed as a reserve law enforcement officer to wear, carry, or display a reserve identification card, badge, or cap, or in any way represent himself or herself to be a member of or connected with the City's reserve police force.

(2) It shall be a misdemeanor for any person appointed as a reserve law enforcement officer to give, transfer, lend, sell, or lease to any other person a reserve officer's identification card

or badge or to permit or allow another person who has not been appointed as a reserve law enforcement officer to wear, carry, or display a reserve officer's identification card or badge.

(3) It shall be a misdemeanor for any person appointed as a reserve law enforcement officer to assist any person who is not an appointed reserve law enforcement officer in representing himself or herself to be a member of or connected with the City's reserve police force.

(b) *Penalties.* Any person found guilty of violating the provisions of this Section, as set forth in Subsection (a), shall, upon conviction, be fined in an amount not exceeding five hundred dollars (\$500) or sentenced to imprisonment for not exceeding six (6) months, either or both, at the discretion of the court trying the cause.

<u>Section 2</u>. This Ordinance shall become effective immediately upon its adoption and publication one (1) time in <u>The Anniston Star</u>, a newspaper of general circulation published in the City of Anniston, Alabama. The City Clerk is hereby ordered and directed to cause a copy of this Ordinance to be published one time in said newspaper.
