Speaking to a Public Hearing Item

In the interest of time and to ensure the fairness of all persons who appear before the City Council to speak for or against a public hearing item, speakers will be limited to three (3) minutes each to address City Council except as described herein. One speaker for the Petitioner may address the City Council for no more than 10 minutes, unless extended by the Mayor. In an effort help the City Council and the general public to better understand the issues, the Mayor may request that a City staff member address the City Council from the podium. Speakers from the general public may only speak when recognized by the Mayor during the public hearing. Speakers will be asked to come to the podium to address the City Council for three (3) minutes and they shall state their name and resident address for the record. Speakers addressing City Council on a public hearing item should coordinate comments in order to respect City Council's time constraints. Groups should select a spokesperson to present the major points that summarize their position and opinions. Speakers are urged to be brief and non-repetitive with their comments. Comments shall specifically address the public hearing item before the City Council, and the speaker shall maintain appropriate tone and decorum when addressing the City Council. City Council may ask questions of the applicant, speakers, or staff during these proceedings only for the purpose of clarifying information. The speaker shall not direct derogatory comments to any individual, organization, or business. At the conclusion of the three (3) minute time period, the speaker will be notified that his/her time has elapsed and the next speaker will be recognized to come forward to the podium and address the City Council. Once the public hearing is closed on an item, there will be no further opportunity for formal or informal public input at a City Council meeting.

VIII. PUBLIC COMMENTS

Public Comment – Speaker Protocol

The City of Anniston believes that any member of the general public should be afforded the opportunity to address the City Council provided that designated rules are followed by the speaker. Any member of the public, who wishes to address the City Council and offer public comment on items within the City Council's jurisdiction, may do so during the Public Comment period of the meeting. However, no formal action will be taken on matters that are not part of the posted agenda. In order to ensure the opportunity for all those desiring to speak before the Council, there is no yielding of time to another speaker. This opp ortunity to address City Council may not be used to continue discussion on an agenda item that has already been held as a public hearing. Matters under negotiation, litigation, or related to personnel will not be discussed. Members of the general public who would like to address the City Council during the Public Comment portion of the meeting, may do so in accordance with the rules outlined in Ordinance 21-O-22 adopted by the City Council on November 2, 2020 as stated:

Section 12. Members of the public may address the Council or speak on matters of public concern during the period of the meeting agenda reserved for public comments, subject to the following procedures:

(a) No person shall be allowed to speak during public comments unless he or she submits a Request to Speak During Public Comments form to the Office of the City Manager no later than 3:00 P.M. on the Friday before the Council meeting. The request shall identify the speaker by name and residential address and shall specify the date of the meeting in which the speaker desires to offer public comments.

(b) The period for public comments shall be open to the first ten (10) persons who submit a timely request to speak during the meeting at hand.

(c) In advance of each meeting, the City Manager shall provide the Council a list of the persons authorized to speak during the period for public comments, not to exceed ten (10) persons, which shall identify the speakers in the order in which their requests were made. The presiding officer shall call on each person from the list. Once recognized, each person shall be provided no more than **three (3) minutes** to complete his or her public comments.

(d) Those persons who make a timely request, after the first ten (10) requests, shall be first on the list of persons authorized to speak during the period for public comments in the next meeting, unless he or she asks to be removed from the list.

Section 13. All comments made by members of the Council shall be restricted to the matter under consideration and shall be addressed to the presiding officer, except during the period of the meeting reserved for Council Comments. All comments made by members of the Council shall be restricted to three (3) minutes, unless the presiding officer grants exception for good cause.

Section 14. No comments shall be permitted by a member of the Council or by a member of the public that is of a disparaging nature or which would constitute a personal attack on the integrity of any member of the Council or the staff of the City.

Once the speaker has been recognized to speak, he/she should not attempt to engage the City Council and/or Staff in a discussion/dialogue and the speaker should not ask specific questions with the expectation that an immediate answer will be provided as part of the three (3) minute time frame since that is not the intent of the Public Comment period. If the speaker poses a question or makes a request of the City, the Mayor may refer the issue or request to the City Manager for follow up. At the conclusion of the three (3) minute time period, the speaker will be notified that his/her time has elapsed and the next speaker will be recognized to come forward to the podium and address the City Council. The Mayor may rule out of order any Speaker who uses abusive or indecorous language, if the subject matter does not pertain to the City of Anniston, or if the Speaker(s) attempts to engage the City Council Members in a discussion or dialogue on issues. City Council shall not discuss non-agenda matters because it does not give the public adequate notice. Accordingly, City Council shall be limited to asking factual and clarifying questions of staff, and when appropriate, the Council may consider placing a matter on a future agenda. In addition, it is not reasonable to expect staff to respond to any of a variety of issues on which they may or may not be prepared to respond to on a moment's notice, so the City Manager may respond, or direct staff to respond at later time.

RESOLUTION NO. 23-R-66

JOINT RESOLUTION WITH THE CALHOUN COUNTY COMMISSION TO CALL A MEETING OF THE OVERSIGHT COMMITTEE OF THE McClellan DEVELOPMENT AUTHORITY

WHEREAS, the Alabama Legislature enacted Act 2009-337, now codified in Title 11, Subtitle 3, Chapter 92B of the Code of Alabama, 1975, to authorize the incorporation of local reuse authorities to manage and promote the reuse and economic development of former military installations within the State of Alabama;

WHEREAS, in doing so, the Alabama Legislature recognized that the economic development of property comprising a former military installation is of vital importance to the life, health, and welfare of the citizens of local cities and counties affected by the base closure;

WHEREAS, the Alabama Legislature further acknowledged the critical need for local reuse authorities to develop closed military installations and to assist counties and cities to develop former military installations for the purpose of promoting industry, trade, and economic development;

WHEREAS, The McClellan Development Authority ("MDA") was incorporated on September 8, 2009, upon application and approval of the Council for the City of Anniston, Alabama and Calhoun County Commission, for the purpose of acquiring, holding, developing, selling, and otherwise disposing of the real and personal property as appropriate for the promotion of industry, trade, and economic development within the former Fort McClellan Military Installation;

WHEREAS, the MDA operates under the direction of a board of directors consisting of one member appointed by the Governor, five members appointed by the City of Anniston, and five members appointed by the Calhoun County Commission;

WHEREAS, in accordance with the enabling legislation, the affairs and operations of the MDA shall be supervised and monitored by an oversight committee composed of all the members of the legislative delegation from Calhoun County, Alabama, as well as the members of the Commission, governing body of Calhoun County, Alabama and the members of the Council for the City of Anniston, Alabama;

WHEREAS, the MDA's oversight committee is required by law to meet not less than semiannually, and otherwise at the call of its chair, who shall be a member of the legislative delegation elected by the committee, or at the call of a majority of the committee's membership;

WHEREAS, the MDA's oversight committee has not met in the last several years, and the oversight committee currently lacks a chairman to call a meeting of the committee;

WHEREAS, the members of the Council for the City of Anniston and the Calhoun County Commission, comprising a majority of the membership of the oversight committee, desire to jointly call an oversight committee meeting to elect a chairman, set a schedule for no less than semiannual meetings, and resume the supervision and monitoring of the affairs and operations of the MDA as mandated by the law governing the MDA and enabling its incorporation as a public reuse authority.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Anniston, Alabama as follows:

The individual members of the Council for the City of Anniston, Mayor Jack Draper, Council Member Jay Jenkins, Council Member Demetric Roberts, Council Member Ciara Smith, and Council Member Millie Harris, do hereby join with the individual members of the Calhoun County Commission, as evidenced by the resolution adopted by the members of the Commission, to call a meeting of the MDA oversight committee for the purpose of electing a chairman of the oversight committee, setting a schedule for the no less than semiannual meetings, and resuming the supervision and monitoring of the MDA's affairs and operations. The Mayor is authorized to set and publish the date, time and place of the oversight committee meeting in conjunction with the Chairman of the Calhoun County Commission.

The members of the Council for the City of Anniston and the members of the Calhoun County Commission, as a majority of the membership of the MDA's oversight committee, request that the MDA, through its Director, the Chairman of its Board of Directors, or such other persons designated by the Board of Directors, present to the oversight committee during the meeting called herein the information and records reflecting the affairs and operations of the MDA since the last meeting of the oversight committee so as to apprise the committee of (a) the real and personal property held, improved, installed, constructed, owned, leased, developed, sold, or otherwise disposed of by the MDA, (b) the MDA's performance of environmental restoration and remediation, (c) the MDA's plans, proposals, strategies and objectives for the development and reuse of Fort McClellan and the promotion of industry, trade, and economic development within the MDA's operational area; (d) the contracts, agreements, leases, bonds, loans, debts, pledges, orders, mortgages, deeds, and other legal arrangements made, entered into, and executed by the MDA to take actions in furtherance of its powers and purposes, (e) the MDA's budget, financial accounts, investments, revenues, earnings, liabilities, and expenditures, (f) the examination of the MDA's books and records by an independent certified public accounting firm and the written audit report rendered annually, (g) the MDA's plans, proposals, strategies, and objectives to achieve all of the purposes for which it was formed, and (h) the MDA's plans, proposals, strategies, and objectives for full payment or extinguishment of all debts and obligations of the authority, the making of adequate provision for its successor to accept or assume all remaining debts and obligations of the authority, and the orderly transfer of the assets, affairs, and operations of the MDA upon its dissolution.

The City Clerk is directed to provide notice of this Resolution to the members of the Board of Directors of the MDA, the Director of the MDA, and each member of the MDA's oversight committee. The City Clerk shall further publish and disseminate notice of the meeting of the MDA's oversight committee called by this Resolution, as scheduled by the Mayor, to provide public notice of the meeting in accordance with the Alabama Open Meetings Act. 4975 Bains Gap Rd, Anniston, AL
